RESOLUTION ORDERING A GENERAL ELECTION TO BE HELD AS A JOINT ELECTION WITH MCLENNAN COUNTY TO BE HELD FOR THE CITY OF ROBINSON, TEXAS ON NOVEMBER 3, 2020 TO ELECT COUNCIL MEMBERS; ESTABLISHING EARLY VOTING AND POLLING LOCATIONS AND DATES/TIMES.

WHEREAS, in accordance with Resolution No. 2011-011, adopted by the City Council in response to Senate Bill 100, the General Election for the City of Robinson for the purpose of electing City Council persons will be held on November 3, 2020 jointly with McLennan County; and

WHEREAS, in accordance with the City Charter and Resolution No. 2011-011 four (4) at large City Council positions will be up for election at the November 3, 2020 General Election.

BE IT RESOLVED AND ORDERED BY THE CITY COUNCIL OF THE CITY OF ROBINSON, TEXAS:

SECTION 1: An election is hereby ordered to be held on November 3, 2020 for voting in the General Election to elect one (1) person for each position to serve the full term of two (2) years for four (4) City Council positions for the City of Robinson.

SECTION 2: That Tuesday, November 3, 2020, is a Uniform Election Day in the State of Texas, and that the election shall be held as a joint general election with McLennan County.

SECTION 3: That the Mayor is hereby authorized and directed to order, and by his signature hereon does so order, a General Election to elect four (4) members to the City Council, be held for the City of Robinson on Tuesday, November 3, 2020 between the hours of 7:00 a.m. and 7:00 p.m. in accordance with the Constitution and laws of the State of Texas, at which all duly qualified resident voters of the City of Robinson, Texas shall be eligible to vote.

SECTION 4: That all necessary election officials, judges and clerks shall be appointed by McLennan County which shall administer the election.
